
# **Quarter Sessions**

#### **Quarter Sessions**

- Justices of the Peace were required by law to meet four times a year to deal with a wide variety of cases
- They could try local criminal cases, not civil cases, treason or forgery
- These latter would be dealt with by the Assize judges
- Quarter Sessions originated in a law enacted in 1326 and met in the first weeks after the feasts of St Michael, the Epiphany, Easter and the translation of St Thomas the Martyr
- In 1830 these dates became the first week after 11<sup>th</sup> October, 28<sup>th</sup> December, 31<sup>st</sup> March and 24<sup>th</sup> June

#### Where and what

- Most Quarter Sessions records are found at local record offices and mainly date from the 18<sup>th</sup> and early 19<sup>th</sup> centuries
- Beside criminal cases they also dealt with local licences and bonds




